SETTLEMENT ORDER AND FINAL JUDGMENT: SECOND SETTLEMENT CLASS

THIS MATTER having come before the Court on November 14, 2005, for the Settlement Hearing as provided in the Court's Order on Plaintiffs' Motion for Conditional Consideration of Settlement Agreement and Provisional Certification of the Prima Second Settlement Class ("Provisional Certification Order") entered on September 16, 2005, due and adequate notice having been given to the Potential Class Members and the Court having considered the Settlement Agreement effective August 1, 2004, between the Plaintiffs and Prima ("Settlement Agreement"), as well as all papers filed and proceedings had herein and all oral and written comments received regarding the proposed settlement, and good cause appearing:

IT IS HEREBY FOUND, ORDERED, ADJUDGED AND DECREED as follows:

1. The parties appeared or were available by telephone, as follows: the named Plaintiffs and Designated Class Representatives through Steven F. Freudenthal (Class Counsel), the Defendant Prima Oil and Gas Company ("Prima") through its counsel Rex Arney and Judith Matlock.

2. No objections have been filed with respect to either the Settlement Agreement or the Settlement Class.

3. The Court, for purposes of this Settlement Order and Judgment ("Judgment"), adopts all defined terms as set forth in the Settlement Agreement.

4. Pursuant to Section 2.5 of the Settlement Agreement, Prima and Plaintiffs have petitioned this Court for certification of a Second Settlement Class as to all or any portion of the Nonproducing Leases for purposes of agreeing on the future royalty payment methodology and future reporting format for such leases. In accordance with the terms of the Settlement Agreement, Prima and Plaintiffs have proposed the certification of a second settlement class composed of two groups. The first group covers the owners of royalty interests in Prima's Nonproducing Leases, as defined in the Settlement Agreement. These parties are hereafter referred to as the Non-Producing Second Settlement Class. The second group covers owners of royalty interests in Producing Leases as defined in the Settlement Agreement who were not included in the First Settlement Class and owners in any other Prima Leases which were not on the lease schedule for the First Settlement Class, all of which leases now have wells located on them (the "Producing Second Settlement Class"). Although the Settlement Agreement contemplated that the second settlement class would only cover Nonproducing Leases, Plaintiffs' counsel and Prima discovered certain parties that own interests in Producing Leases who may be entitled to payment of royalties but who were not included in the First Settlement Class for various reasons including owners in wells for which title was still being examined at the time the list of owners for the First Settlement Class was created. The Court approves the request of Plaintiffs and Prima to amend the Settlement Agreement by adding to the second settlement class these owners of interests in the Producing Leases and owners in any other Leases not included in the First Settlement Class which have or have had Prima-operated wells on such Leases.

5. The owners included in the Non-Producing Second Settlement Class and the owners included in the Producing Second Settlement Class have been timely presented to this Court in accordance with the terms of the Settlement Agreement and together make up the Second Settlement Class.

6. The Court finds that the Designated Class Representatives and Class Counsel were diligent in the conduct of settlement negotiations and have adequately represented the Second Settlement Class.

7. Pursuant to Rule 23 of the Wyoming Rules of Civil Procedure, the Court certifies, for settlement purposes only, a Second Settlement Class consisting of all persons identified on Exhibit A. A copy of Exhibit A is attached hereto and incorporated by reference herein. Excluded from the Second Settlement Class are federal, state and local governmental entities and other persons as provisionally certified in the Provisional Certification Order; and those Potential Class Members for whom no mailing of notice was successfully made as set forth in Exhibit A attached to *Class Counsel's Report*.

8. The issues and claims settled involve the computation and payment of royalties. Neither the pleadings nor the Settlement Agreement raise or address: (1) issues or claims with respect to surface damages; or (2) issues or claims with respect to the ownership or decimal interest of an owner in lands in which communitization, pooling or unitization occurred; such issues or claims are not within the scope of the Settlement Agreement and are also excluded from this Judgment.

9. Pursuant to Rule 23(b)(3) of the Wyoming Rules of Civil Procedure, the Court finds and concludes with respect to the Second Settlement Class and for settlement purposes only that:

(a) The members of the Second Settlement Class are so numerous (approximately 254) that joinder of all Second Settlement Class Members is impracticable;

(b) There are questions of law or fact common to the members of the Second Settlement Class which predominate over any questions affecting only individual members;

(c) The claims of the Designated Class Representatives and named Plaintiffs and the defendant's defenses to those claims are typical of the claims of the Second Settlement Class;

(d) The Designated Class Representatives and named Plaintiffs and Class Counsel have fairly and adequately represented and protected the interests of the Second Settlement Class members;

(e) A class action is superior to other available methods for the fair and efficient adjudication of the controversy considering: (i) the interests of the members of the Second Settlement Class in individually controlling the prosecution of separate actions; (ii) the extent and nature of any litigation concerning the controversy already commenced by members of the Second Settlement Class; (iii) the desireability or undesireability of concentrating the litigation of these claims in this particular forum; and (iv) the difficulties likely to be encountered in the management of the class action.

(f) In determining whether the requirements of Rule 23(b)(3) of the Wyoming Rules of Civil Procedure have been satisfied for purposes of certifying a class for settlement purposes, the Court has taken into account the fact of settlement and its impact upon the elements required for certification of the Second Settlement Class. Among other impacts of settlement, the Court need not inquire whether the case, if tried, would present intractable case management problems since the result of settlement is that there will be no trial.

10. The Court has jurisdiction over the subject matter of the action, the Designated Class Representatives, the named Plaintiffs, the other members of the Second Settlement Class and the Defendant, including but not limited to claims under Wyo. Stat. § 30-5-301 et seq. ("Wyoming Royalty Payment Act").

11. The Court finds that the distribution of the Notice of Proposed Class Action Settlement as provided for in the "Order on Plaintiffs Motion for Conditional Consideration of Settlement Agreement and Provisional Certification of the Prima Second Settlement Class" constituted the best notice practicable under the circumstances to all persons within the definition of the Second Settlement Class, and fully met the requirements of Rule 23 of the

Wyoming Rules of Civil Procedure, due process and applicable law under the Wyoming and United States Constitutions.

12. Pursuant to and in accordance with the requirements of Rule 23 of the Wyoming Rules of Civil Procedure, the Court approves the settlement of the above-captioned action as set forth in the Settlement Agreement as fair, just, reasonable and adequate as to the settling parties. Based upon the pleadings, testimony and representations of counsel, the Court concludes that: (i) the Settlement Agreement was fairly and honestly negotiated in an adversarial context accompanied by extensive review of the relevant documents, accounting records and applicable law; (ii) serious questions of law and fact exist, *inter alia*, the demarcation between deductible costs and non-deductible costs, application of the \$100.00 reporting assessment and calculation of applicable interest, placing the ultimate outcome of the litigation in doubt; (iii) the value of an immediate recovery outweighs the mere possibility of future relief after protracted and expensive litigation; and (iv) the judgment of the parties that the settlement is fair and reasonable is evident throughout the pleadings and briefs.

13. The Court awards attorneys fees and costs to Class Counsel in the amount of fifteen percent (15%) of the aggregate settlement amount based on the majority rule of a "percentage of the fund method," plus Administrative Costs in the amount of \$7,214.00. From this amount, Class Counsel shall pay or be reimbursed for costs, expert expenses, and expenses of settlement administration. In reaching this amount, Class Counsel had reduced the application for attorneys fees and costs from the thirty percent (30%) provided in its retainer agreements, to the amount requested. Whether applying the "lodestar method" or the "percentage of the fund method," the requested award of fifteen percent (15%) for attorneys fees and costs is fair and reasonable.

14. The parties to the Settlement Agreement are to perform in accordance with the terms set forth in the Settlement Agreement. As of the Approval Event for the Second Settlement Class, the

Second Settlement Class Members shall be deemed to have released Prima Corporation and the Additional Released Parties as provided in the Settlement Agreement whether or not the Second Settlement Class Member endorses and presents a Distribution Check. Following the Approval Event, each Second Settlement Class Member shall become fully bound by all of the releases and other obligations and conditions as set forth herein and in the Settlement Agreement. Except as necessary to enforce this Order and the Settlement Agreement, Named Plaintiffs, Second Settlement Class Members, and their heirs, personal representatives, successors and assigns are barred from bringing claims against Prima and the Additional Released Parties for Settled Claims as specifically defined in the Settlement Agreement.

15. Neither the Settlement Agreement nor any proceeding, act performed or document executed pursuant to or in furtherance of the Settlement Agreement: (i) is or may be deemed to be or may be used as an admission of, or evidence of, the validity of any Settled Claim, or of any wrongdoing or liability of the Defendant; or (ii) is or may be deemed to be or may be used as an admission of, or evidence of, any fault or omission of the Defendant in any civil, criminal or administrative proceeding in any court, administrative agency or other tribunal. Defendant may file the Settlement Agreement and/or the Judgment from this Action in any other action that may be brought against them in order to support a defense or counterclaim based on principals of res judicata, collateral estoppel, release, good faith settlement, judgment bar or reduction of any theory of claim preclusion or issue preclusion or similar defense or counterclaim. Defendant has denied and continues to deny each and all of the claims alleged in the action. The Designated Class Representatives, named Plaintiffs or any other member of the Second Settlement Class may file the Settlement Agreement in any proceeding brought to enforce any of its terms or provisions.

16. The Court reserves exclusive and continuing jurisdiction over the action, the Designated Class Representatives, named


Plaintiffs, the Second Settlement Class and the Defendant for purposes of supervising the implementation and enforcement of the Settlement Agreement and this Judgment. This Judgment shall be a Final Judgment as defined by Rule 54(b) of the Wyoming Rules of Civil Procedure.




